GUIDELINE

The updated National Clinical Guideline for Stroke is on track for publication this Spring. Almost 3000 papers have been considered and over 600 papers fully reviewed by topic experts from across the UK & Ireland. For the first time the guideline will be published online only with a comprehensive search function. Click here for more information and to sign up so you are notified when the 2023 guideline, and accompanying plain language summary, are published.

The next edition of the guideline will be published in spring 2023. It will be a limited update of the fifth edition. The Intercollegiate Stroke Working Party decided in early 2021 to restrict the update to those areas where expert consensus from each speciality identified that evidence and practice have changed, rather than to undertake a comprehensive update of the entire fifth edition.

NEW USER GUIDES

The new user guides provide guidance on how teams (Inpatient, non-inpatient and 6 month assessment providers) can use the webtool to enter data, information on SSNAP reports, the analysis tools available and further user resources and support.

Each pack is bespoke to the type of team to make it easy for existing and new users to find help.

Non-inpatient teams: 6th February 2023 (July-December 2022 discharges).


Ambulance teams: 22nd February 2023 (October 2022 admissions).

Critical Time Standards: 7^h February 2023 (January 2023 admissions) and 6th March 2023 (February 2023 admissions)
