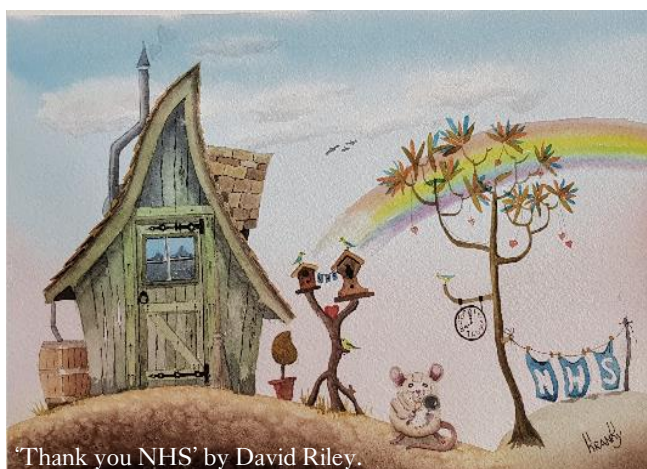

WHAT WE'RE WORKING ON AT THE MOMENT

- Finalising the dataset we want to collect for the acute organisational audit.

Data locking deadlines:

- Inpatient teams: 2nd August (April-June 2021 data).
- Non-inpatient teams: 2nd August (January-June 2021 data).
- Ambulance teams: 22nd July (March 2021 data).

REPORTING UPDATES

SSNAP are now producing reports for Integrated Stroke Delivery Networks (ISDNs). You can view ISDN-level reports in our [results section](#) (Results > Clinical audit > Regional-ISDN). SSNAP are now reporting ethnicity breakdown at team, national and ISDN level (tab F, Casemix).

In addition to 5-day therapy targets, SSNAP are now reporting against 7-day therapy targets for occupational therapy, physiotherapy, and speech and language therapy at team and national level (tabs J/K team-centred/patient centred post 72h).
